A NEW PRESIDENT FOR PEABODY COLLEGE

Dr. John Dunworth, 49, Dean of the Teachers College at Ball State University has been named to succeed Dr. John M. Claunch, effective Jan. 1, 1974, as President of George Peabody College for Teachers, Nashville, Tennessee. Dr. Claunch, 67, who celebrated his sixth anniversary as Peabody President August 1, 1973, will retire June 1, 1974, following a sabbatical leave beginning Jan. 1, 1974. Dr. Dunworth, in his position as Dean at Ball State, was responsible for the administration of the Teacher's College which served 10,000 students in teacher education from undergraduate through doctoral level programs. Dr. Dunworth, who had been Dean at Ball State since 1966, holds the Doctor of Education degree in educational administration and supervision from the University of Southern California.
